ACMH Update – Jane Shank

Jane was not available for an update. She provided a written update and attachments to the group ahead of time. Group had no discussion.

DHHS Updates - Phil Kurdunowicz, Lindsay McLaughlin, Kim Batsche-McKenzie, Justin Tate, Mary Chaliman - MDHHS Kim Batsche-McKenzie reported that Sec. 996. From the funds appropriated in part 1 for family support subsidy, the department shall make monthly payments of \$229.31. \$300.36 to the parents or legal guardians of children approved for the family support subsidy by a CMHSP. She spoke about data monitoring and quality improvement section of the Children's Division. She introduced Justin Tate, Stacy Farrell, Phil K and Lisa Collins. Justin spoke about Family Driven Youth Guided Policy. Justin spoke about partnership efforts between the Department and the Education System. Stacey is working with a team to develop and formalize processes for highly complex situations, urgent clinical matters, etc. for youth. They are working to establish a collaborative effort with Hospitals for youth who are transitioning out of Hawthorn. They are also working on clinical consultations and troubleshooting with PIHPs. These are all being focused on children across all systems. As documents begin to emerge and become final, they will be shared with this group by the Department. Phil Kurdunowicz spoke about division updates – hiring – services for Children with I/DD including Autism spectrum has Dr. Mary Luchies. Section 924 - PIHP rates - The Department issued a memo clarifying these actuarially sound rates. Also, the Department released a memo about recertification process. Phil then spoke about MI Kids Now. He stated that certain teams are active now – two are new – Community reintegration process team, and placement and treatment options team. Release for the grant program (request for proposals) is available on the EGrAMS page. Workforce development leadership team update – Brad Behren has moved to a new role in managed care oversight division, and Lisa Collins will be stepping into his role. Mobile Crisis RFP states that only CMHs and PIHPs can apply. Phil stated that first cohort launches Jan. 1st, and second cohort launches May 1st. If you are receiving funding currently for ICSS, you are urged to apply for the Jan. 1st cohort.
