





Board Bylaws and Policies

Bylaws are the document containing the highest level of basic rules of your Board principally relating to the Board's governing of its members and the regulation of its affairs.

Policies are the overall high-level plan embracing the general goals and acceptable procedures of the Board.



MENTAL HEATLH CODE

Michigan ACT 258 OF 1974 CHAPTER 2-COMMUNITY MENTAL HEALTH PROGRAMS CHAPTER 2A-SUBSTANCE USE DISORDER

Mental Health Code

The Mental Health Code is maintained by the Legislative Services Bureau, which compiles and publishes state laws.

State laws are made by our elected officials serving in the state legislature, and signed into law by the Governor.

As Board members we are part of a government organization, we must uphold the laws as written in the Mental Health Code.

Mental Health Code Act 258 of 1974

"An ACT to codify, revise, consolidate, and classify the laws relating to mental health; to prescribe the powers and duties of certain state and local agencies and officials and certain private agencies and individuals; to regulate certain agencies and facilities providing mental health or substance use disorder services; to provide for certain charges and fees; to establish civil admission procedures for individuals with mental illness, substance use disorder, or developmental disability; to establish guardianship procedures for individuals with developmental disability; to establish procedures regarding individuals with mental illness, substance use disorder, or developmental disability who are in the criminal justice system; to provide for penalties and remedies; and to repeal acts and parts of acts."

Mental Health Code - Chapter 2

Sets out Michigan Department of Health and Human Services (MDHHS) relationship to the Community Mental Health (CMH) Network

Designates that County Commissioners appoint Board Members

Directs the makeup of Community Mental Health Service Program (CMHSP) Boards

Gives Board Members the directive to Appoint the Executive Director of the CMHSP

Sets out the duties of Board Members

Open Meetings Act Act 267 of 1976

The Open Meetings Act is a Michigan law requiring meetings of public bodies, including our CMH Boards, be open to the public with notice of those meetings. Failure to comply with the Open Meetings Act may cause invalidation of Board decisions with penalties.

MDHHS Michigan Department of Health and Human Services

The Michigan Department of Health and Human Services is a principal department of the State of Michigan, headquartered in Lansing, that provides public assistance, child and family welfare services, and oversees health policy and management. Responsibilities specified in the Mental Health Code and the Public Health Code are carried out by the Behavorial Health and Developmental Disabilities Administration located within MDHHS.

MDHHS holds contracts with the CMHSPs and the PIHPs

PIHP Prepaid Inpatient Health Plan

A PIHP is an organization that manages the Medicaid mental health, developmental disabilities, and substance abuse services in their geographic area under contract with the State.

Since January 1, 2014, Michigan has ten (10) PIHPs responsible for managing the Medicaid resources for behavioral health and intellectual /developmental disabilities services for Medicaid and Healthy Michigan enrollees.

CMHSP Community Mental Health Services Program

CMHSPs and the organizations with which they contract provide a comprehensive range of services and supports to children, adolescents and adults with mental illnesses, developmental disabilities and substance use disorders in all 83 Michigan counties.

The Mental Health Code states: CMHSPs are accountable to local citizens through the county Board of Commissioners which appoints the twelve (12) person CMH Board of Directors. Volunteer CMH board members establish the policy direction for the programs consistent with the state and federal law, standards and guidelines. The Board of Directors has one employee, the CEO of the CMHSP. One-third of the CMH board members statewide are required to be primary persons served and those caring for family members. CMHSPs are fully accountable governmental entities, thereby ensuring that persons served are protected, and that there is public participation in system decision-making and equitable access to services.

HIPPA Health Insurance Portability and Accountability Act

HIPPA is a federal law designed to provide privacy standards to protect a patient's medical records and other health information provided to health plans, doctors, hospitals and other health care providers.

State of Michigan - Michigan Department Health and Human Services (MDHHS) is in charge of enforcing the HIPPA privacy rule.

TRAININGS

Mental Health First Aid Training

Mental Health First Aid was created in 2001 by a nurse specializing in health education and a mental health literary professor in Australia in collaboration with a non-profit health promotion charity focused on training and research in Australia.

The United States is just one of the many countries that have adopted the program from Australia. Mental Health First Aid is a national program to teach the skills to respond to the signs of mental illness and substance use.

Recipient Rights

In compliance with the Michigan Mental Health Code, the Recipients Rights State Office advocates for people who receive mental health services by offering recipient rights protection.

Recipient Rights Training will provide knowledge of the laws required to carry out the mandates of the Mental Health Code pertaining to Recipient Rights.

State of Michigan, Recipient Rights Training, is available through your agency.



Ethical Challenges Example #1


At a Board meeting, a newly appointed Board member, whose family member has been receiving services from your community mental health agency, makes it clear that it is the new Board member's priority to protect the rights and services of *their* individual family member.

Ethical Challenges Example #2

One of your Board members has experience in public relations. She is coming into staff offices unannounced wanting to offer their thoughts and asking questions. Staff says they are focused on completing their projects according to their assignment guidelines, but do not want to offend the Board member.

Ethical Challenges Example #3

The press contacts you as a member of the Board for comment on why you voted to eliminate some services. You decide to grant the interview because your family will get to see your picture in the paper and, you will finally get respect from your spouse.
